Please note no action will be taken until the filing fee is paid, or the Affidavit has been approved by the Judge.

Once the Motion has been filed with the Court, then the other party will be notified and a pretrial conference will be scheduled. You are allowed to appear by phone and/or videoconference at the pretrial conference. However, if a trial date is set, then you must appear in person for the trial.

Mediation is encouraged, and may soon be required before the Court will modify an existing Order regarding custody of children. For more information regarding mediation, please contact me.
