DV Staff host sexual assault awareness activities during the month of April

April was sexual assault awareness month (SAAM) and although the offices may have been open for appointments only, that did not stop the Domestic Violence (DV) department from providing awareness on this important topic.

Our DV employees were busy finding creative ways to show support for SAAM. Information and other outreach materials were posted to the PTN website, Facebook,

and other social media platforms. Several office sites had window art to raise awareness of sexual violence.

The DV program held a Start By Believing Campaign and took pictures of staff throughout all the office sites who signed a pledge stating: When someone tells me they were raped or sexually assaulted, I pledge to Start By Believing.

We also held an event for National Crime Victims' Rights Week from April 19-25 with a logo and white ribbon

that individuals could print, color, and hang in their windows at home or work. Teal Day was also recognized on April 22nd where all employees were asked to wear teal, which is the color that represents sexual assault awareness month.

Denim Day is an international day that is celebrated to help show support in one of the most casual of ways. This year's Denim Day was held on April 29th and employees were asked to show off their denim on this day and take pictures.

Our Training and Outreach Specialist, Donna Wolff, was able to line up online training with Legal Aid of Nebraska on Working with Native American Victims of Violence. Donna even had to schedule a third training on this topic due to the high response.

World Elder Abuse Awareness Day | June 15, 2020

It can be hard to imagine that anyone would deliberately want to harm an elderly person, but unfortunately, elder abuse does occur. Some instances of elder abuse are intended to exploit the person financially; you've probably heard of scams targeting elders. In other cases, caretakers simply don't provide the basic necessities, like nutritious food, appropriate medication, safety, or assistance with hygiene. Help spread the word this June 15th, which is World Elder Abuse Awareness Day. If

you see something, say something.

Why World Elder Abuse Awareness Day is Important:

- Elders may be unable to advocate for themselves

Many elders are not in a place to stand up for themselves, whether it's because they're physically frail or because they're scared of speaking up and fear repercussions. It's crucial for all of us to be on the lookout for signs of elder abuse, and to speak up if something seems wrong.

- Elders deserve our re-

spect and our attention

In the Native American culture, elders are revered—and rightfully so. Their experiences, memories, and perspective on life are valued for the lessons that younger folks can learn. And if older people aren't encouraged to pass along the skills and wisdom they have accumulated during their lives, then the culture as a whole suffers. We owe it to older generations to ensure that their latter stages of life are not tarnished by neglect.

- It reminds us to look out for each other

It's easy to see bad things and not say anything—whether that's elder abuse, or someone bullying another person. But this awareness day reminds us just how important it is to look after, and look out for, our friends, family, and especially elders. It reminds us to exercise compassion on a daily basis, and care about others rather than just ourselves.

Recently the Ponca Workforce Innovation and Opportunity Act (WIOA) program was able to assist Megan Lindy, a member of the Rosebud Sioux Tribe.

Megan initially reached out to the Workforce Development office in Scottsbluff for assistance. They, in turn, referred her to the WIOA program

when they realized they would be unable to assist Megan with all of her needs in obtaining her certificate in Business Administration from Western Nebraska Community College. With the help of both agencies, Megan was able to receive assistance with tuition and school supplies.

After obtaining her Business Administration certificate Megan will be looking for employment

within an office or state job setting so that she positions herself for good benefits and a set schedule, allowing her to spend more time with her children. Future goals are to continue her education in Management Information Systems.

The Ponca WIOA Program staff have offices in Lincoln, Norfolk, and Ralston serving the entire state of Nebraska as well as Woodbury and Pot-

tawattamie counties in Iowa and Charles Mix County in South Dakota. Answering questions regarding Brownfields

What is a Brownfield?

Simply put, a Brownfield is a property that could potentially contain some sort of contamination that could potentially cause harm and make it hard to resell or redevelop. This can include places such as old abandoned buildings, illegal dumpsites, old gas stations or auto repair shops, buried tanks, and asbestos and

lead paint. These sites are not necessarily contaminated but they could be.

Are they the same as a Superfund site?

Not really. Brownfield sites do not have the same degree of contamination. Superfund sites typically come from manufacturing facilities, processing plants, landfills, toxic waste dumps, mining/smelter sites, and even sometimes dry cleaning facilities.

What kind of education do you need to be a TRP?

Typically, a TRP would have a degree in biology, earth science, chemistry, or geology. Basically, you have to have a good understanding of chemicals and their properties, as well as how they could move through the environment.

Does the Ponca Tribe have Brownfield sites?

Any Brownfield site listed

by the Ponca Tribe can be found on our website under the Environmental Department Program tab. Most have been cleared or are in the process of being cleared.

RESOLUTION 20-25

WHEREAS: The Ponca Tribe of Nebraska is a federally recognized Indian Tribe (P.L. 101-484) whose business affairs are conducted by the Ponca Tribal Council as defined in the Constitution approved July 22, 1994 by the Acting Deputy Commissioner of Indian Affairs; and

WHEREAS: Pursuant to the Constitution of the Ponca Tribe of Nebraska, the Ponca Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such powers contained in the constitution; and

WHEREAS: The Ponca Tribal Council has reviewed the proposed Title XVII – Environment Code which is a requested addition to the Ponca Tribe of Nebraska Law & Order Code; and

WHEREAS: The Tribe wishes to exercise its sovereignty and federal delegated authority to protect the environment within the territory of the Tribe and therefore, the purpose of Title XVII.

WHEREAS: The proposed Title XVII addition to the Law & Order Code was placed on the March 23, 2020 Tribal Council Agenda to allow comments from the public and on April 6, 2020 and April 20, 2020 for first and second readings respectively. A notice of intent to amend the Law & Order Code adding Title XVII - Environment was mailed to all heads of household at least 14 days prior to any final action satisfying the requirements for the adoption, amendment, or abolishment of Ordinances.


THEREFORE BE IT RESOLVED that the Ponca Tribal Council approves the amendment to the Ponca Tribe of Nebraska Law & Order Code addition of Title XVII – Environment.

BE IT FURTHER RESOLVED that these amendments shall take effect immediately.


CERTIFICATION

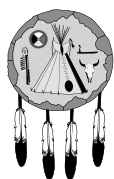
